8. New Business

8.1. 2021/22 Budget

Budget was asked to be adjusted to include \$ 500 for the Bulletin and \$1500 for Junior Chess. Accepted Patterson / Hack, passed, adjustments can be found in Appendix 2

8.2. 2021/22 Tournament Schedule

Victoria Chess is planning the following events:

- BC Close in October
- Jack Taylor Memorial in November
- BC Open is in the planning
- Victoria Open is to be scheduled (possibly)
- Washington accepted the match to be in January 2022 in Richmond.

There was a discussion over Hybrid tournaments and what the possibility is, this is up to the organizers, it was mentioned that it is likely a challenging task.

Another discussion was brought up around Online tournaments. It was noted that it has been a burden on the organizers to look into fair play issues, and some of those issues are often unanswerable.

8.2.1 Transition back to OTB tournaments

There was a discussion, and suggestions to follow the guidelines by the government. Discussion went on for children under 12 that they wouldn't be fully vaccinated with the COVID-19 vaccine, which might have some challenges for organizers to allow entries with fully vaccinated people. Ultimately it is up to the organizer to set the boundaries of the tournament.

8.3. BC Closed proposal

Proposed to be in Victoria, with a \$1600 support from the BCCF. Room costs are expected to be \$149 for players in the tournament. Accepted Lo / Panoulis. The proposal is added to this report in Appendix 4.

8.4. BC Women's Championship

It was discussed to be best to be held separately. In addition it was mentioned that it would be challenging to find candidates, since there are requirements to be able to participate, example was given of the number of games played minimum.

The best location would likely be the lower mainland due to the active women chess players.

There were some conversations whether it could be combined with the BC Closed, however the conversation was inconclusive. No proposal was put forward.

8.5. Women BCCF Executives

We talked about how Women in the BCCF Executives need to be promoted. Some of this conversation was driven by the NOC NSF and CFC drive to get more women in executive positions.

8.6. Website

There were complaints brought up about the website, some of them are:

- Not updated
- Not clearly able to find information
- Not enough information
- It does not look "nice"

In addition there were two main concerns:

- We haven't heard from our current webmaster
- New data is not updated.

8.7. Special Resolution re Voting by Electronic Means

Henry Chiu brought forward the following piece to our attention:

This is a notice of a special two-thirds vote resolution to add the following subsections of the Constitution at the next general meeting of the Society:

“Whereas Section 83 of the [BC Societies Act](#) allows meeting attendance by electronic means, be it resolved that the following subsections be added to Section 17 of the [BCCF Constitution](#):

17e) All members attending a general meeting by electronic means are deemed to be attending in-person for the purpose of subsection 17a of the Constitution as long as the members are able to participate in it per Section 83 of the BC Societies Act.

17f) Despite subsection 17c or any other sections of the Constitution, the Society has no obligation to make provision for a secret ballot to a member attending by electronic means per subsection 17e).”

I would like to add the constitution changes as a similar situation may happen again in the future. In addition, we may want to have a hybrid (in-person & electronic) meeting model after the pandemic to encourage attendance.

Stephen pointed out to Henry that under the Society Act the text of the special resolution needed to be sent out with the AGM announcement 3 weeks prior to the meeting, rather than being received on the day of.

Discussion around this point was that it was not necessary to have this changed in the constitution, and can be as part of the operational practices.

If this will be carried forward the timeline will be:

- To be discussed in AGM 2022
- To be voted on in AGM 2023

8.8 Promoting women in Chess

There was a discussion on how to make it more attractive for women in chess. Ideas that were tossed around was to have a large prize fund for women. Making the perceived value for women in chess higher. Examples in this area: have a separate BC Women's Championship, have separate women's categories. Additionally promoting women's chess by having strong women chess players play a simul. Or give lectures and answer questions.

Appendix 1 - President's Report

This report covers a two-year period and falls conveniently into two parts. In 2019/2020 the trends of record tournament turnouts or highs not seen for thirty or forty years continued. Our expenses were normal: the support of provincial championships, travel grants for provincial champions to participate in national championships, and support of clubs and schools.

Then the pandemic arrived. Our last OTB event was the 2020 BC Open which attracted 161 players, this despite over forty withdrawals. Since then such events that have taken place have been online. In this regard I would particularly like to acknowledge the tireless work of Paul Leblanc in continuing to organize tournaments during this time. (These events have sold out with the exception of the BC Senior, which indicates the degree to which our tournaments consist of or are reliant upon junior entries). Since our membership model is based on tournament participation our income has not suffered as much as it might have. Conversely our expenses have been much reduced, which means we are actually in better financial shape than usual.

As health restrictions lessen the BCCF, like society in general, waits to see what new 'normal' awaits us. Large OTB events are being held in the U.S. and hopefully we can offer the same here before too long. The BCCF will endeavour to continue to support and promote chess in the coming year, in whatever form it may take.
